

## Parent's or Guardian's Participation Agreement of Waiver of Liability, Indemnification and Medical Release

The undersigned parent and/or legal guardian does hereby acknowledge that he/she is aware that the European Championship 2020 (hereinafter the Event) is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include but are not limited to actions of other people including, but not limited to, participants, volunteers, spectators, event officials; lack of hydration, weather, and/or other natural conditions. The undersigned parent and/or legal guardian acknowledges that the participant voluntarily elects, and the parent and/or legal guardian supports the participants decision to participate in this Event with knowledge of the danger involved.

In consideration for being allowed to voluntarily participate in the event, on behalf of myself, the participant, his/her personal representatives, heirs, next of kin, successors and assigns, the undersigned parent and/or legal guardian forever as follows:

- Waives, releases, and discharges from any and all liability for the death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to the participant or the participant traveling to and from this event the following:
  - Organizers of the event organizers
  - Event volunteers
  - Event sponsors
  - Any other officials or third parties linked to the organization and holding of the event
- Indemnify and hold harmless all entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities, if the participant's actions during the Event be classified as reckless (this includes however is not limited to NOT following the safety rules, NOT following the Regulation, NOT following the instructions given by the Organizers) or should any of the participant's actions be deliberately intended at causing harm.

The undersigned parent and/or legal guardian certifies that the Participant is physically fit, has sufficiently trained for participation in this event and has not been advised otherwise by a qualified medical person.

The undersigned parent and/or legal guardian acknowledges that this Waiver of Liability, Indemnification and Medical Release form will be used by the Organizers of Motogymkhana European Championship 2020, and the sponsors of the event.

The undersigned parent and/or legal guardian consents to the Participant receiving medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during this event.

The undersigned parent and/or legal guardian understands that at this event or related activities the Participant may be photographed. The undersigned parent and/or legal guardian agrees to allow photos, videos, or film likeness featuring the Participant to be used for any legitimate purpose by the Organizers, Sponsors, and/or Assigns.

This Waiver of Liability, Indemnification and Medical Release document shall be construed broadly to provide a release and waiver to the maximum extent permissible under the applicable law.
